Arts & Culture Grant Program: 2024 Guidelines

Community Foundation for MetroWest (CFMW) envisions a region where artistic and cultural initiatives are centered as a key component to cultivating vibrant communities and a sense of belonging for all residents. Our mission for the 2024 Arts & Culture Grant Program is to invest in local nonprofit organizations whose primary mission is to provide access to arts and cultural initiatives in the region.

This year, the Community Foundation for MetroWest seeks to award **one-time general operating grants of up to \$10,000*** to support arts & culture nonprofits in MetroWest. Grant decisions and amounts will be determined based on a variety of factors, including:

- Organization size understanding the impact of a grant of this size for your organization
- Location(s) of impact demonstrating commitment to MetroWest and role in the region's cultural ecosystem, including strong collaboration and partnership
- Organization impact and reach -including population served, type(s) of programs offered, etc.
- Organization's leadership and financial health
- Alignment with the Foundation's priorities outlined below

*Maximum grant size will be 10% of the organization's annual operating budget or \$10,000, whichever is less. Average grant size in 2023 was \$5,200.

In 2024, the Foundation will be prioritizing organizations that demonstrate a commitment to and strong mission alignment with one or more of the following:

- Proactively providing equitable and open access to arts education, visual arts, or performing arts initiatives for under resourced and underrepresented residents
- Celebrating and/or preserving the region's history and dynamic and ever-changing cultural heritages
- Encouraging and increasing opportunities for culturally diverse voices and communities to create and participate in arts & cultural activities
- Promoting arts & culture as an engine of social and economic vitality in the region
- Fostering innovation, community collaboration, and community-driven programming

As our MetroWest communities continue to change and evolve, we recognize the importance of arts & culture to help us learn, connect, thrive, and celebrate one another. We look forward to hearing how we can consider supporting nonprofit partners in need of additional funding to sustain their efforts or transform their work to benefit MetroWest.

GRANT PROCESS

The 2024 grant cycle is an online process and will operate based on the following timeline:

٠	October 7 – November 1	Follow up conversations or site visits, as needed***
٠	Early December	Applicants notified of decisions via email

***Please note that we are unable to visit every applicant due to limited capacity. If you are not chosen to receive a site visit, this in no way serves as a reflection of your organization or your likelihood of receiving funding.

ELIGIBILITY

Applicants must:

- Have 501(c)(3) tax status as a registered nonprofit organization OR have an eligible fiscal sponsor
- Not discriminate in the hiring of staff or the provision of services on the basis of race, religion, gender or gender identity, sexual orientation, age, national origin, or disability
- Serve one or more of the following MetroWest cities/towns: Acton, Ashland, Boxborough, Carlisle, Concord, Dedham, Dover, Framingham, Harvard, Holliston, Hopkinton, Hudson, Lexington, Lincoln, Marlborough, Maynard, Medfield, Medway, Milford, Millis, Natick, Needham, Sherborn, Southborough, Stow, Sudbury, Walpole, Waltham, Wayland, Wellesley, Westborough, Weston, Westwood

Ineligible organizations or requests include:

- City/town agencies, including libraries
- Individuals
- Schools private, public, pre-K, charter, or Chapter 766
- Human service organizations providing arts-based programs to their clients
